

How to Enroll in a Monthly Payment Plan

Overview

Students currently enrolled at SCU are eligible to enroll in a monthly payment plan to assist with budgeting needs, on a term basis. **There is a \$40 non-refundable enrollment fee** per term/semester.

Payment Plan Criteria:

- Student must be enrolled at SCU.
- First payment and payment plan enrollment fee are due when you enroll into the plan.
- Total payment plan amount will be based on current account balance minus applicable financial aid.
- Enrolling in the payment plan requires a checking/savings account, and are processed via ACH.
- Plans are subject to automatic rebalancing on the 5th of each month based on enrollment and/or financial aid changes. This means your monthly payment amount may change accordingly, and you will receive email communication notify you of any such changes.
- Participants must enroll into a new payment plan each term. There is no automatic re-enrollment.

This quick reference guide will cover how to navigate through Workday to external systems to **Set up a Payment Plan for the Term.**

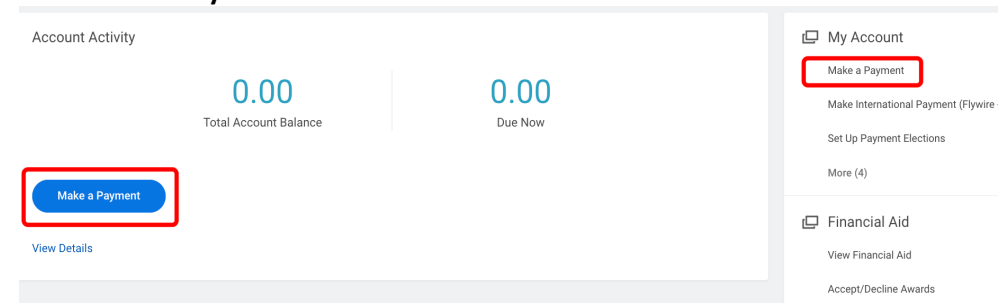
Process

1. After logging into Workday, click the **Finances** icon on your home page.

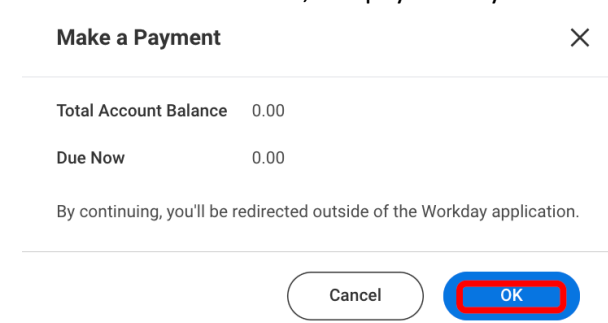


The **Finances** dashboard provides quick links to your Account Activity, Make a Payment, **Setup Monthly Payment Plan**, Payment Elections, 1098T information and Financial Aid.

2. Click **Make a Payment**.



3. Click **OK** to be transferred to Transact, our payment system.



4. Select **Overview** or **Payment plans** on the left-hand menu. Click **View payment plan options** in the payment plans box.

Plan Details

Enrollment fee: There is an enrollment fee of \$40, due upon enrollment, to participate in this plan. This fee covers your school's administrative costs associated with the plan, and is in addition to the plan amount of \$31,457.
