The three committee members present at this meeting agreed to vote on the ad hoc designee via email and, if approved, the designee would be invited to attend meetings starting the Spring 2024 quarter. P&TS will email an anonymous poll to all voting members of the committee.

4. Update on adding Tesla electric vehicle charging stations (EVCS) to reinstated pricing model update

Setting up a pricing model for the SCU Tesla stations is underway. Additional Tesla charging stations may need to be installed before Tesla assists with the current pricing implementation along with access to Tesla dashboard services. Campus communication efforts would ensue prior to the implementation of charging customers at the Tesla EVCS.

5. ENVS 195: Campus Sustainability Project Update

This course will review our current EVCS pricing model and assess new areas across campus where EVCS may be installed to better serve the campus community. Below are the areas our dedicated ENVS 195 group of students will assist us with our needs by the end of March 2024. Feedback regarding additional ways the ENVS 195 group may assist our P&T Advisory Committee should be directed to transportation@scu.edu

- a. Expansion of EVCS across campus
- b. Pricing structure review and feedback from SCU community
 - i. Charging per kilowatt hour vs. hourly rate
- 6. Research on cost per kWh
 - a. What SCU is paying Silicon Valley Power (SVP) for EVCS
 - i. \$0.18/kWh (SVP, solar and Bloom) from December 2023 billing

This baseline takes into account the recent 10% increase that SVP instituted.

7. Meeting update on potential sliding scale model

Two committee members met with representatives from Human Resources (HR) to discuss the possibility of revising the current parking permit pricing structure to a sliding salary scale model. The basis of the model would be to create a pricing model that takes into account one's income and bases the permit price on the amount they make each year. HR was receptive to the idea of providing needed data to assist with this project. Data points provided by HR would be anonymous. They suggested rather than using salary grades, a number of tiers that span tiered salary ranges could be applied more universally since salary structures differ between faculty and staff. Data collection could start with staff and faculty who are currently set up with salary deduction and P&TS could assist HR by running a report of faculty and staff names who purchased parking permits during the 2023-2024 academic year. Creating a model like this would likely involve raising the rate for higher tiers (individuals making the most money per

year) to offset the cost of parking permits for lower tiers (individuals making the least money per year). Preliminary research at institutions of higher learning was shared and served as part of the rationale for implementing such a model, a topic previously recommended by the Staff Senate. A committee member suggested attending Staff Senate meetings and providing ongoing feedback by way of surveys to see if this continues to be a topic of interest among staff so the P&T advisory committee does not waste time pursuing an agenda item irrelevant to staff.

Previously, Caltrain informed the department that they would need to purchase train passes for all SCU constituents in order to qualify for a subsidized rate for interested constituents.
- P&TS will run a report of faculty and staff names who purchased parking permits during the 2023-2024 academic year.
- P&TS committee members will resend an email message regarding the City of Santa Clara's residential parking enforcement. (Implemented January 1, 2023)
