### **2026-2027 Financial Aid Appeal for Need-Based Reconsideration**

#### **Purpose of Form**

Through the Higher Education Act, Santa Clara University Financial Aid Office has been granted the authority to exercise professional judgment to account for a student's special circumstances that differentiate his/her current financial or family situation from that reported on the 2026-2027 Free Application for Federal Student Aid (FAFSA). By submitting the Financial Aid Appeal for Reconsideration form, a student is requesting consideration for a specific change in his/her financial or family circumstances.

We make every effort to respond as quickly as possible; however, the response time may be up to 4 weeks.

**NOTE:** *In most cases, approved appeals of this type will only result in a change to your federal and/or state financial aid.*

#### **Important Notes**

- 1. You must complete the 2026-2027 Free Application for Federal Student Aid (FAFSA) for any consideration.**
- The situations listed on this form are those situations that the Santa Clara University Financial Aid Office will review for possible changes in financial aid eligibility.
- If your FAFSA was selected for verification, the verification process must be completed before we can exercise professional judgement.
- In most cases, you may be required to provide tax return transcripts and/or documentation for verification purposes.
- In addition to completing the 2026-2027 FAFSA, the Financial Aid Appeal for Reconsideration form, and providing the proper documentation, you must also submit a detailed statement to explain the change in your financial or family circumstances.
